The Select Board will hold a hearing to receive input from the public on the proposed South Street reconstruction project. The project is scheduled for funding in 2026 as part of the MassDOT Transportation Improvement Program (TIP). Reconstruction will occur from the North Attleboro town line northerly to Sharlene Lane. Changes include repaving the entire section of roadway, reconfiguring parking and cross walks, adding an 8-foot-wide multi-use pedestrian/bicycle path on both sides of the road and landscaping. Additional utility installations are also anticipated prior to the road repaving. While minimal land takings are proposed, there are several instances where items installed by abutting property owners that are located within the existing roadway right of way will need to be removed or relocated.
