## PARK COMMISSION MINUTES

October 23rd, 2025

2025 DEC 22 AM 9:49

Meeting was called to order at 7:00pm by Chris Faille.

Present: Jason Morneau, Chris Faille & John Teiner (Park Department). Jeanne Taylor – Plainville Lions Club, Plainville residents – Maggie C, Stanley W & Brenda W from Spirit of Plainville. Meeting was held in person at the Park Department office (142 South Street). Recorded on North TV.

Chris Faille made a motion to accept the minutes of September 18<sup>th</sup>, 2025. Motion was seconded by Jason Morneau. Park Commissioners signed Payroll FY26W8P.

Park Commissioners, Lions Club & Spirit of Plainville groups discussed and planned our annual Winter Festival & Tree Lighting in honor of Mr. James Faille. Date will be Saturday 12/6/25. 4-7PM food truck will be on site (SOP booked), Girl Scouts will do ornaments and crafts and help countdown the tree lighting. Lions club – will donate hot chocolate and donuts. SOP will raffle off tickets to light the bonfire (6 total). Spirit of Plainville will order banner and install at town park entrance for Winter Festival. J. Teiner will get popcorn donation (Showcase Cinema NA), and Gift Card donation from Stop & Shop for candy canes.

Park Director (J. Teiner) spoke with Plainville Fire Chief (JR Skinner) and confirmed if the weather holds up, the Plainville Fire Department will be able to bring back the bonfire for the Winter Festival for the 1<sup>st</sup> time since 2019. J. Teiner will coordinate with Plainville Police and DPW for road closure and traffic details.

J. Teiner rented boom lift from Sunbelt rentals for FOD to have the facility department help take down the new sunshield behind the Babe Ruth (Spadoni Field) diamond for the winter. Lift was also booked for hanging up the tree lights with our volunteers on Saturday Nov 15<sup>th</sup>, and Sunday Nov 16<sup>th</sup>, 2025.

Fall youth rec soccer program at the Plainville Town Park has 174 children registered. Last day and Trophy Day for our Fall rec soccer program will take place on 11/8/25. Only concern and problem with the Fall rec soccer program is due to the large number of children registered and only 50 parking spaces in the town park parking lot.

NEW Youth Tennis in the park program with USTA coach/instructor has been a huge success. 18 children registered from 1<sup>st</sup> to 5<sup>th</sup> grade. Programs last day/class will be on Sunday 11/2/25 at Malia's Courts.

1<sup>st</sup> after-school rec program of the school year has been booked. After-School Rec basketball from Kindergarten to 6<sup>th</sup> grade in the Jackson School & Wood School Gym has been scheduled. Registration is still going on for the program we currently have 69 children registered. Program will start 11/10/25.

Registration is now open for our Youth Rec Winter basketball program on Saturdays with Norfolk & Wrentham Rec. This will be our 5<sup>th</sup> year since joining Norfolk and Wrentham Rec for the winter Youth Basketball program. Program will start on Saturday 12/6/25.

Warrior youth Field Hockey board meet with John Teiner, went over intro meeting, league info/rules and potential field rentals for the youth organization to rent FOD Unlikely story field 7v7 in the spring and fall.

J. Teiner presented to the Park Commissioners the CPC Designee form from the Town Clerk. Roy Blakely Called and approved the appointment of Jason Morneau as our representative. Chris Faille made a motion to reaffirm Jason Morneau as the Park Department CPC representative, motion was seconded, all in favor.

Next Park Department meeting will be held on December 18th, 2025, at 7:00PM.
