Street Opening Bylaw Attachment — Fee Schedule
Ch. 395, Art. I

Application fee: \$50.

Inspectional services after normal working hours: \$50 per hour.

Nominal Schedule of Refundable Deposits for Street Opening Work in Public Ways

To open to center of public way	\$300 each opening
To open across the public way	\$600 each opening
To open to center of state highway	\$1,500 each opening
To open across a state highway	\$2,000 each opening
To open trench in unpaved shoulder (parallel to street)	\$10 per linear foot
To open trench in paved public way (parallel to street)	\$25 per linear foot
Curb cut for a private driveway	\$200
Curb cut for a subdivision street	\$500
Newly paved roads (infrared or equivalent)	
To center of public way	\$700
Across the public way	\$1,400
To open a sidewalk (includes three square yards)	
Bituminous concrete sidewalk	\$300
Concrete sidewalk	\$600
To excavate a sidewalk (over three square yards)	
Bituminous concrete sidewalk	\$15 per square yard
Concrete sidewalk	\$25 per square yard

Note: The actual amount of each refundable deposit shall be reasonably determined by the awarding authority or its representative to be sufficient to secure applicant's performance under this bylaw.
